

Meeting was adjourned at 8:14pm.


Q1 When you have a local issue or concern, where do you turn for help? (check all that apply)

Q2 If you've ever interacted with the SCNC, How would you rate your experience?





Q3 Which current issues concerning Studio City cause you the greatest concern? (e.g. homelessness, Harvard Westlake, crime)



Q4 What does the Studio City Neighborhood Council do? (check all that apply)





Q5 Would you be willing to participate with the SCNC on a committee or project?





Q7 How would you prefer to find out about SCNC meetings, news, events, and programs? (check all that apply)


