Section 2: Quorum - The quorum shall be eight (8) voting Members of the Board. No official action may be taken in the absence of a quorum.

**Section 3: Official Actions** - An Official Action may occur after Quorum has been established and a motion passes with the requisite number of votes, usually a simple majority of those present and voting.

**Section 4: Terms and Term Limits** – Board Members shall serve a two (2) year term commencing after being seated, or until the next election. A Youth Member who turns eighteen (18) during his term of office shall complete his term and become a voting member.

Section 5: Duties and Powers – The Poard shall establish policies and positions of the Council at its regular and special meetings, and review and recommend actions to governmental and other entities on issues affecting the community. The President shall be the spokesperson of the Council. No other individual Member of the Board shall speak for the Board or otherwise publicly represent a Board position unless authorized to do so by the President or an official action of the Board.

**Section 6: Vacancies** – The President shall appoint replacements to vacancies on the Board as per the Operating Procedures.

**Section 7: Absences** - A Board member shall be automatically removed from the Board upon two (2) unexcused absences from regularly scheduled Board meetings or upon two (2) unexcused absences from regularly scheduled meetings of committees of which the Board member is a member. An unexcused absence shall occur when a member cannot provide the President or Committee Chairperson a reasonable explanation for the absence.

Studio City Neighborhood Council's (SCNC) acceptable forms of documentation for each category are listed below. Voters may qualify to vote in more than one, and if so, will need to provide the required documentation for each category.

#### At-Large Stakeholder (vote for 1 candidate)

is at least 18 years of age on the day of the election who declares a stake in the Studio City Neighborhood Council Area, must provide a valid photo ID with name and address.

#### Business Representative (vote for 3 candidates)

or business property owner within the boundaries of the SCNC will need to provide 2 pieces of documentation. All documentation provided to a reasonable extent, show the stakeholder's name and the name and address of the business within the boundaries of Studio City. Please have one piece of documentation from List A and one from List B, or two from List B.

List A: Valid CA Driver's License, Valid CA Identification Card, Valid Passport.

List B: Business Lease or the Business' Rental Agreement, Commercial Mortgage Statement or Lease Receipt, Current City of LA Business Registration Certificate, Los Angeles County Property Tax Bill.

#### Employees/Independent Contractors Representative (vote for 2 candidates)

Any stakeholder, who is at least 18 years old the day of the election, who legally provides goods and services for compensation in Studio City, whose compensation is reported by way of a Form W-2 or Form 1099 and does not need to maintain a City Business Registration Certificate. Please have one piece of documentation from List A and one from List B, or two from List B.

List A: Valid CA Driver's License, Valid CA Identification Card, Valid Passport.

List B: A Form W-2 or Form 1099, Letter from Employer on Business Letterhead verifying employment, Pay check stub.

#### Residential Homeowner Representative (vote for 4 candidates)

A Residential Homeowner, who is at least 18 years old the day of the election, residing at their residence in Studio City. Please provide any 2 of the following pieces of documentation to vote in this category:

List A: Valid CA Driver's License, Valid CA Identification Card, Valid Passport.

List B: Los Angeles County property tax bill, Mortgage Statement, Homeowner's Association Bill, Homeowner's Insurance Documentation, Assessor's Identification

#### Residential Renter Representative (vote for 3 candidates)

A Residential Renter in Studio City needs to provide two (2) pieces of documentation. All documentation provided must, to a reasonable extent, show the stakeholder's name and the name and address of the place you rent in the boundaries of Studio City. Please have one piece of documentation from List A and one from List B.

List A: Valid CA Driver's License, Valid CA Identification Card, Valid Passport.

List B: Residential lease or rental agreement, Rent Payment Receipt, Renter's Insurance Documentation, Letter from Landlord confirming renter/tenant status.

#### Service Organization Representative (vote for 2 candidates)

Any stakeholder who is at least 18 years old the date of the election who is a member or full time employee, of separate service organizations located within the Studio City boundaries and on the SCNC Board certified list will need the following documentation to vote in this category. Please provide 2 pieces of documentation. All documentation provided must, to a reasonable extent, show the stakeholder's name and the name of the approved service organization. Please have one piece of documentation from List A and one from List B, or two from List B.

List A: Valid CA Driver's License, Valid CA Identification Card, Valid Passport.

List B: Pay check or stub, a letter on the organizations letterhead stating that you are a substantial and ongoing active participant, membership card or participation certificate, receipt of membership dues, staff/membership roster

#### Youth Representative (vote for 1 candidate)

A stakeholder, aged of 15-18 years old on the date of the election is eligible to vote for a youth representative by providing the following. One piece of documentation from List A or two from List B. At least one document of the two from List B must prove your age.

List A: Valid CA Driver's License, Valid CA Identification Card, Valid Passport, Valid School ID with address and Date of Birth (DOB)

List B: Birth Certificate or Other similar documentation proving you meet the youth ages qualifications.
