PUBLIC INPUT DURING THE OUTREACH COMMITTEE MEETINGS

The public is requested dial *9 if accessing the meeting by telephone or if accessing the meeting by computer to click on the "raise hand" button, when prompted by the presiding officer, to address the Committee on any agenda item before the Committee takes an action on an item.

Comments from the public on agenda items will be heard only when the respective item is being considered. Comments from the public on other matters not appearing on the agenda that are within the Committee's jurisdiction will be heard during the General Public Comment period. Please note that under the Ralph M. Brown Act, the Committee is prevented from acting on a matter that you bring to its attention during the General Public Comment period; however, the issue raised by a member of the public may become the subject of a future Outreach Committee (or General Board) meeting.

Both "General" and "Agenda Item" public comment is limited to two minutes per speaker, unless adjusted by the presiding officer of the Committee. **If a stakeholder wishes for more time to speak, the request must be made to the Chair immediately, before the comment is heard.** Adding time to the amount allotted for public comment is at the privilege of the presiding officer.

Please note, there are reasonable rules of decorum that preclude a speaker from disrupting, disturbing or otherwise impeding the orderly conduct of its meetings, per Brown Act § 54954.3(b) and § 54954.3(c).
