"The Board of the Studio City Neighborhood Council requests the City of Los Angeles become a zero or ultra-low emissions ground maintenance operation, similar to the one adopted by the City of South Pasadena."

"The Board of the Studio City Neighborhood Council asks Councilmember Paul Krekorian to request from the LAPD their policies and procedures for the enforcement of the [Municipal 112.04\(c\) gas-powered leaf blower ban](#). Additionally, we ask that Councilmember Krekorian receive a quarterly update on their enforcement metrics to share with the community."

"The Board of the Studio City Neighborhood Council requests South Coast Air Quality Management District to include City of Los Angeles in their annual Leaf Blower Exchange Program, but remove the gasoline-powered model in the options. Also, to enlist all Elected Officials, City Departments/Services, Mayor's Office of Sustainability, DWP, Libraries, etc. to promote the program and have a 12-month education/outreach to the public on the ban."

1. "The Board of the Studio City Neighborhood Council requests Council District 2 to publicly share the tree removal report received from CFAC. The public notice shall be easily accessible and timely available via a new static "Tree Removal" page connected to the current <http://www.paulkrekorian.org/environment> webpage."

Motion would be sent to a) CD2 b) Public Works

2. Establish due process and replacement trees for tree removal under new sidewalk repair program. Potentially "halt" rebate program until program short-term and long-term plan is defined along with key performance indicators (costs, success drivers, etc.)
3. Request City of Los Angeles, DWP, and Department of Urban Forestry establish a proper tree care program/guideline instead of tree trimming (stop the mal-pruning, get skilled inspectors, minimize "2nd trip back", etc.) and infringement violators/violations rehabilitation program. Also, demand a quality control (backend) system to verify tree trimming processes keep to guidelines.
4. Request Bylaws or Budget Committee to create a MOU and guideline for SCNC funding on Sustainable/Environmental/Green projects brought to Board. May include (a) Final

maintenance/replacement plan presented at time of funding request, (b) Guidelines on what SCNC receives as to SCNC icon on site, eblast to recipients' followers/patrons/etc., (c) Establish standards of "health of projects" Year over Year for 10 year period and if any are not meeting standards, funding request will be denied until standards met (d) Articulate the financial partners tied into project besides the request to SCNC (% project owned per entity), (e) Provide 3 quotes for SCNC to pay directly for best vendor/service with funding request (f) Plans for project, including plant selection, are approved by SCNC Board if funding is 40% or more of entire project (preference NATIVE plants before any other option), (g) All project plans are presented up front when funds are requested and IF anything alters from approved plans, the funds would be frozen until new plans are reviewed...in otherwords Board does not approve "changeable" plans, (h) no permanent branded signage larger than 8.5x11 at site for any SCNC funded projects, etc. from committee.
