Motion: The Board of the Studio City Neighborhood Council approves allocating up to \$1,500 for office equipment and supplies for the SCNC office and conference room including, but not limited to, a new printer, replacement toner cartridges and other office supplies as needed and approves a reduction of \$820 from last month's allocation to the SCNC Outreach Committee for the "Movies In The Park" programs.

Motion A: The Board of the Studio City Neighborhood Council supports the tentative track map at 12041-49 Guerin Street [TT-72705] for a 16 unit condominium development with the attached conditions (Exhibit A).

Motion A: The Board of the Studio City Neighborhood Council does not support the budget advocates white paper recommendations. We do support the efforts of our Counilmember Paul Krekorian to continue to take a fiscally responsible approach to the establishment of priorities in the budget process.

Motion B: The Board of the Studio City Neighborhood Council requests that the Los Angeles City Council support AB 2222 but that it request that AB2222 be amended to keep the convenant related to the affordable housing units be maintained for the life of the project and not be allowed

to expire in 55 years. We authorize the President of the Studio City Neighborhood Council to submit a letter to Assembly Member Nazarian (1) requesting that AB2222 be amended to require that the convenant related to the affordable housing units be maintained for the life of the project and not be allowed to expire in 55 years and (2) to indicate the SCNC support of AB2222.

Motion C: The Board of the Studio City Neighborhood Council passed a motion with respect to the mobility plan at its meeting on April 16, 2014. We supplement that motion with the following specific requests:

- The Bike Lane Ordinance was amended to show no bike lanes on Ventura Blvd. in Studio City. We request that specific conforming language be added to the Mobility Plan to state that there will be no bike lanes on Ventura Blvd. in Studio City.
