# Motion 4.18.07-12a 1. Article C. VOTING RIGHTS

1. Each Stakeholder who is 18 years of age or over prior to the election shall be entitled to one (1) vote for each open position on the Board. Each stakeholder who is age fourteen (14) through seventeen (17) prior to the election shall be entitled to one (1) may vote for the Youth Board position.

a. No cumulative voting is allowed, i.e., a stakeholder may not cast more than one (1) vote per candidate. Voting by mail may be allowed if so directed by the Board **\*No changes to existing Article C.1** 

2. The vote shall be taken and results tallied and announced at the close of each election (and according to other rules established by the Board) which process shall be open to all Stakeholders.

# change to Article C. 2 as follows:

The votes shall be tallied only after the poll(s) have closed and announced immediately after the results are determined, subject to such other rules as may be established by the Board and approved by DONE. The voting, tallying and announcement of election results shall be the responsibility of the IEA and shall be open to all Stakeholders, who may observe, but in no way interfere with, influence or otherwise disrupt the election process Notwithstanding the foregoing, no! candidate shall be allowed on the premises of a polling site, except for the time required to vote, from the opening of the polling site(s) until the election is declared closed. Candidates are allowed to observe counting.

3. All elections shall be determined by plurality of vote.

4. All elections shall be by secret/anonymous ballot.

### Motion 4.18.07-12b Change to Article C. 3 & elimination of 4 as follows:

3. Elections shall be conducted by secret ballot and results determined by a plurality of votes. Ties, if any, shall be decided by a coin toss supervised by the IEA immediately following the tally and prior to the announcement of election results. This explanation needed when change is presented to DONE for approval

# *Motion 4.18.07-12c* Change to Article VIII as follows:

### ARTICLE VIII - BOARD

The Board shall consist of fifteen (15) Stakeholders as follows:

- A. Two (2) One (1) at-large Stakeholders
- B. Three (3) Four (4) residential homeowners (including condominium owners)
- C. Two (2) residential renters (inclusive of apartments, condominiums, multiplexes, and singlefamily dwellings)
- D. Three (3) Four (4) business owners
- E. One (1) business property owner
  - F. One (1) employee of a business located within the Area.
- G.. Three (3) <u>Two (2)</u> members of service organizations identified by participation in educational or faith-based institutions, community services, youth, business and special-interest organizations that are located in the community and that meet regularly in the community. The Board may also include one or more ex-officio members appointed by the Board. These members are entitled to all rights and privileges afforded other Board members, exclusive of the right to vote on items that come before the Board.

# The Board shall include one (1) ex officio youth member, age sixteen (16) or over, elected by his or her Stakeholder peers under the same provisions as those for the election of other Board members for a term of one (1) year.

The Board shall include one (1) ex-officio Youth member, who is at least sixteen (16) years of age, but less than eighteen (18) years of age as of the date of the then-current election who shall be elected by his or her Stakeholder peers under the same provisions as those for the election of other Board members, for a term of one (1) year.

All committees, subcommittees, and/or ad hoc committees shall be formed in accordance with Article VII of the Operating Procedures of the Studio City Neighborhood Council.

<u>Motion: 4.18.07-12d</u> Provided that the proposed changes to the Studio City Bylaws as stated herein is approved by DONE and, that notification is received in writing by the Studio City Neighborhood Council from the Greater Toluca Lake Neighborhood Council advising that the Greater Toluca Lake Neighborhood Council has changed its bylaws in conformity with the changes as stated below, then this Board approves and adopts the following changes to the Studio City Neighborhood Bylaws.

# Article III Definitions

Add paragraph "L".

"Shared Jurisdiction" Shall mean any matter, concern or impact whatsoever involving North Weddington Park and/or South Weddington Park and/or Rio Vista Elementary School.

### Article IV Duties of Officers of the Board

Add: In the event Studio City receives notice of any matter, concern or impact on or involving North Weddington Park and/or South Weddington Park, and/or Rio Vista Elementary School

the Secretary shall without further Board action within five days of receipt of such notification notify Greater Toluca Lake Neighborhood Council in writing either by mail or e-mail.

### Article VII

Delete: EAST: in its entirety

Add:

EAST: US 101 / LA River; Lankershim Boulevard; Shared Jurisdiction with Greater Toluca Lake Neighborhood Council: North Weddington Park and South Weddington Park; Rio Vista Elementary School; Lankershim Boulevard to Fredonia Drive; the boarder between zip codes 91604 and 90068; boarder between zip codes 91604 and 90068 where it intersects Mulholland Drive (just west of Torryson Place and approximately 7700 Mulholland Drive).

## 13. Land Use Committee Report & Board Action - Kessler

<u>Motion 4.18.07.13a</u> The LUC recommends that the SCNC Board oppose the tract map application for the project at 4318 and 4322 Whitsett Ave., including for the following reasons:

- 1. Six balconies and large windows will face R1 properties to the east
- 2. The developer has failed to make reasonable efforts to maintain existing mature trees

3. The height of the two stairwell towers on the west and the east sides of the building is

- unacceptable and the towers are too close to the front and back facades
- 4. The project does not presently include sufficient landscaping acceptable to the Committee
- 5. The subterranean setback in front is insufficient to permit the growth of mature trees
- 6. The design is out of character with the community
- 7. No shade and light study has been undertaken

<u>Motion 4.18.07.13b.</u> The LUC recommends that the SCNC Board support the proposed conditional use permit for the sale of distilled spirits at Sushi Katsu Ya, 11680 Ventura Blvd. with the limitation that hours of operation will not exceed current hours of operation (Monday through Thursday from 11:30 a.m. to 10:00 p.m., Friday and Saturday from 11:30 a.m. to 10:30 p.m. and Sunday from 11:30 a.m. to 9:30 p.m.).
