# Motion to repair the River Walk between Whitsett and Laurel Canyon

In order to enhance the community's enjoyment of the Los Angeles River Walk between Whitsett Avenue and Laurel Canyon Boulevard, and to correct the dangerous condition resulting from improper drainage and algae on the asphalt surface on the south bank, the Studio City Neighborhood Council asks the City of Los Angeles Department of Recreation and Parks to:

- 1. Remove the asphalt walkway/bike path on the south bank of the river.
- 2. Repair the drainage.
- 3. Replace the asphalt with decomposed granite also known as DG
- 4. Replace the dangerous, broken fence on the north bank.
