<u>Motion A:</u> In response to increased difficulty in connecting via phone to local LAPD precincts, the Studio City Neighborhood Council supports the council motion (<u>CF17-0225</u>) requesting that the LAPD, with the assistance of the Information Technology Agency (ITA), report on its current phone-based customer service systems including new measures to ensure that individuals who call LAPD stations are informed of the different methods available to contact the department, such as 1-877-ASK-LAPD, online crime reporting, Text-A-Tip, etc; instituting a modern phone customer service system that includes an automatic customer call back function that would enable an individual who calls a station to leave a message and be called back by a LAPD representative, rather than being place on hold or 2 transferred to 311; and adding functionality to the department's phone system that would correctly route calls to either the divisional level or the responsible City department.

<u>Motion A</u>: The Board of the Studio City Neighborhood Council opposes adoption of an ordinance creating affordable housing units by establishing a process for granting legal status to certain existing unpermitted dwelling units in multiple-family buildings, and amending Subsections (a) and (e) of Section 19.14 of Chapter 1 to clarify the applicability of previously approved fees to the administration of the program. Our opposition is based upon (i) the resulting increase in density through the use of State density bonus provisions requiring incorporation of restricted affordable units into the existing buildings without providing parking required if the units were not given the exemption proposed in the ordinance, and (ii) the failure to actively enforce the requirement to reserve and maintain the Affordable Units for 55 years.

Conditions for Service Industry Establishments in Studio City

- The authorized use shall be conducted at all times with due regard for the peaceful, quiet, enjoyment of the neighborhood and users of adjacent properties.
- 2. Exterior signs must comply with the Ventura / Cahuenga Boulevard Corridor Specific Plan or the Los Angeles Municipal Code, whichever is more restrictive.
- Any "door charge" collected shall be for the sole benefit and use of the entertainer.
- All graffiti on the site shall be removed or painted over within twenty-four (24) hours of its occurrence. If graffiti is painted over, the paint over paint color shall match with the existing paint color.
- The use and development of the property shall conform with the floor plan submitted with these conditions to all regulatory agencies with jurisdiction.
- No music or amplified sound shall be allowed in any outdoor area and no music or amplified sound shall be audible beyond the property line.
- 7. Business shall close at <u>*QfM*</u> on Sunday through Thursday and close at <u>on Friday and Saturday</u>. *Qally Open a G Am*
- 8. All usage of outdoor seating areas shall cease at 11:00 PM seven (7) days per week.
- The name and telephone number of the general manager and the owner shall be publicly posted inside and outside the facility.
- 10. The manager and all employees shall be made aware of all these conditions. As a condition of employment, all employees must read and sign a statement that acknowledges their understanding of the conditions placed on the establishment. These forms must be maintained in a file on the premises and be available for public inspection during the hours of operation.
- 11. If there is a controlled access to an establishment, a door person limiting in the ingress of the public, when a member of the public requests to see the posted permits, management is required to provide immediate access.
- 12. The owners shall consult with and abide be all regulatory agencies.
- 13. No opaque coverage of windows above three feet from ground level.
- 14. One trash can and a minimum of two commercially manufactured smokeless freestanding cigarette containers must be placed in front of the location during hours of operation. The establishment including any Outdoor Serving Areas must comply with LAMC 41.50. smoking regulations.
- 15. Valet service provided by or for the establishment must abide LAMC 103.203 AND 103.203.1 Division 8, Article 3, Chapter 10.
