- A) City of Los Angeles Campaign Finance Ordinance (185799) -- Studio City stakeholders acknowledge proposed revisions to the Regulations of the City Ethics Commission concerning matching funds made on October 5, 2018 by Mike Bonin, the council member from the 11th District and Paul Koretz, the council member from the 5th District. [CIS <u>12-1269-S5</u> and 15-1088-S1]

MOTION 7A: The board of the Studio City Neighborhood Council intends to send a formal letter of invitation to council members Bonin and Koretz to discuss their motion and the current state of City Elections with the board and stakeholders.

B) County Sole Source Contracts -- Los Angeles County supervisors recently adopted a \$32.8 billion supplemental budget, marking the final step in the

County's annual budget process and reflecting an ongoing commitment to serving vulnerable residents, addressing a broad range of emerging needs and improving the quality of life throughout the region. The Government Affairs committee discussed the use of 'sole source' agreements by the County and State law at it's November meeting.

"The purpose of requiring governmental entities to open the contracts process to public bidding, according to an important CA appellate case Konica Business Machines U.S.A., Inc. v. Regents of University of California, is to: eliminate favoritism, fraud and corruption; avoid misuse of public funds; and stimulate advantageous market place competition . . . The importance of maintaining integrity in government and the ease with which policy goals underlying the requirement for open competitive bidding may be surreptitiously undercut, mandate strict compliance with bidding requirements."

MOTION 7B: The Studio City Neighborhood Council requests that the Board of Supervisors elaborate on the Sheriff's justification for <u>a sole source agreement</u> with Motorola for portable radios that the Board approved October 30, 2018. A clarification would assure stakeholders that this procurement does not set the stage for continuing related procurements which, if conducted in this sole source manner, could cost the county an additional \$35,000,000.

8. Public Safety Report by Craig Radow

MOTION 8A: Based on crime statistics, negative resident and business proprietor feedback, and the lack of action from our elected leaders, the Studio City Neighborhood Council is deeply concerned regarding the direction of public safety in the East Valley. The City of Los Angeles is inadequately protecting local stakeholders as LAPD resources are not sufficiently being directed to our local police divisions; thus, resulting in a lack of suitable patrol and an increase in violent crime:

Violent Crime is up +8.7% in North Hollywood division while citywide it is down -2.7%

Aggravated Assault is up +13.3% in North Hollywood division while citywide it is down -0.3%

Robbery has increased +6.1% in North Hollywood division while citywide it is down -4.6%

The highest among all Valley divisions, "Calls for Service" in the North Hollywood bureau have increased +9.9% YTD (this % increase is above both the Valley bureau and city wide average)

(Crime stats presented are between 1/1/18 to 10/20/18 vs. comparable 2017 period)

Effective immediately, we demand suitable funding, resources, and appropriate personnel allocation for the North Hollywood and Van Nuys police divisions.
