### **SUBJECT: MOTION TO CENSURE**

We, the undersigned members of the Studio City Neighborhood Council Board, in accordance with the Resolution by the Board of Neighborhood Commissioners, Uniform Policy for Board Member Censure, bring forward a Motion to Censure against Mr. Richard Adams, an appointed Studio City Neighborhood Council Board Member.

While Mr. Adams has a track record of inappropriate comments to stakeholders on NextDoor (for example, on or about May 20th, during an online conversation about the use of face masks, Mr. Adams got into a disagreement with Sue Ellen Wagner and he told her to FAOD, an acronym meaning F\*&\$# Off and Die. Again, Mr. Adams did not distinguish whether he was speaking as a Board Member or a private citizen) and combative comments to our Department of Neighborhood Empowerment representative (for example, on September 18, 2019, Mr. Adams was verbally abusive to Jose, who was stepping in for Gibson N., from the Department of Neighborhood Empowerment. Additionally, Councilman Paul Krekorian's Field Deputy, Jessica Fugate, sent an email to the Studio City Neighborhood Council President and Vice President on November, 13, 2019 requesting that we "remind" Mr. Adams of what is appropriate in tone and content when communicating with the Councilman's Office.) that violate the Code of Conduct for both the Department of Neighborhood Empowerment and the Studio City Neighborhood Council Code of Civility, this motion specifically addresses an email sent by Mr. Adams on June 2nd, at approximately 8:23 PM to existing Board Members, committee members, and an unknown number of stakeholders. In his email, he stated the following: the "protest" in Hollyweird is apparently over, or at least LAPD doesn't have any streets closed there anymore, as they did earlier, according to Sigalert.com but they are reporting that Thug Life Inc is congregating at Garstasi's mansion, and have been since just after 5 PM. since he as given them the run of the City so far, it would be poetic justice, at least in my opinion, if any looting and destruction tonight started there. a taste of his own medicine might do him some good, but something tells me LAPD will get different orders there, than they get when it's the average persons home or business being threatened by the mob.

at least i can honestly say i didn't for the incompetent dishonest scoundrel.

It is worth noting that Mr. Adams, as a private citizen, is free to say whatever he would like, with a few exceptions and we are not attempting to curtail his rights. However, Mr. Adams utilizes the same email address for both official and unofficial communications which makes it confusing to any email recipient as to whether his commentary is in his official capacity as a Board Member or as a private citizen. Regardless of the capacity of his comments, as a public figure seated on a public board, he agreed to adhere to the Code of Conduct.

We, the undersigned Board Members, feel his comments are a violation of our Code of Civility, which is enshrined in the Code of Ethics for all NCs and states the following: Policy Number 2014-2(2)

Attachment A

1. Neighborhood Council Board Members should conduct themselves in a professional and civil manner.

2. Neighborhood Council Board Members should treat other Board Members and members of the public with respect regardless of the other's opinion, ethnicity, race, religion, religious belief or non-belief, color, creed, national origin, ancestry, sex, sexual orientation, gender, gender expression, age, disability, marital status, income, homeowner status, renter status or political affiliation.

The above two sections do not state that these principles only apply while the Board is in session. Thus, we assert they apply to Mr. Adam's email of June 2nd as these principles apply to all board members at all times.

Further, a stakeholder, who is also a long-time Studio City Neighborhood Council volunteer and former Committee Chair received Mr. Adams' June 2nd email. This stakeholder then sent an email to the Board stating "It also appears a current appointed board member sees this all as Thug Life, Inc, which is a race-baiting dog-whistle, and I want no part of this nor have my name associated with any form of this disgusting racism."

Mr. Adams replied with another email:

LOL...

i'm not a coward: i BCC'd them on that, just as i did you.

and please identify the comments you feel are "racist" in my previous e-mail: interested bystanders await your opinions, should you wish to actually take a definitive stand.

additionally, what "sanity" issues are there, andwhat are your credentials as a healthcare professional to make that claim? last i heard, you were in "The Industry" and as such, unqualified to make such diagnoses. given your overwrought response, it's likely \*you\* are the one with undiagnosed issues, but that is beyond my scope of practice as a healthcare professional, so i will leave it to you and your therapist to discover the facts of the matter. or, you could just let your tantrum go and admit you, and others, over reacted to my protected First Amendment\* speech you disagreed with. you likely won't. but society lives on hope.

As shown in the above excerpt from Mr. Adams' email, he continued to disregard the Code of Conduct in which he agreed to "treat other Board Members and members of the public with respect regardless of the other's opinion."

Upon introducing this June 2nd email to the Board President, Mr. Brian Carroll took action to remove Mr. Adams as Chair of the Outreach Committee, which is his right as President. Specifically, Mr. Carroll's email stated: Richard Adams, I hope this email finds you well.

You are hereby removed as chairperson for the SCNC Outreach Committee.

Thank you for your service to the community.

Mr. Adams replied:

LOL.

has the First Amendment been suspended along with all our other civil liberties i apparently threw away 21 years of my life, physical wellness and overall life expectancy to defend, so that "outrage" mobs could "cancel" ideas they don't agree with? just curious...

please tell me if you think i wasted that part of my life. i'm pretty sure i already know your answer, but i'd like to see you take a definitive stand, even once.

Mr. Adams has repeatedly violated the spirit of speaking in a respectful manner. We further assert that Mr. Adams' interactions violated Paragraphs 4 and 6 of the Code of Conduct, which state the following:

Policy Number 2014-2(2)

Attachment A

4) Neighborhood Council Board Members should not use language that is threatening, obscene, or slanderous, including profanities, insults or other disparaging remarks or gestures directed toward other Board Members.

6) Neighborhood Council Board Members should not engage in "bullying" or harassment which is generally defined as follows: a. "Bullying" is conduct that meets all of the following criteria:

i. is reasonably perceived as being dehumanizing, intimidating, hostile, threatening, or otherwise likely to evoke fear of physical hand or emotional distress;

ii. Is directed at one or more Board Members;

iii. Is conveyed through physical, verbal, or technological means;

iv. Substantially interferes with participation opportunities, benefits, or programs of one

or more Board Members at Neighborhood Council sponsored activities or events;

v. adversely affects the ability of a Board Member to participate in or benefit from the Neighborhood Council programs or activities by placing the Board Member in reasonable fear of physical harm or by causing emotional distress; and,

vi. Is based on a Board Member's actual or perceived protected characteristic (see 2 above), or is based on an association with another person who has or is perceived to have any of these characteristics.

In consideration of the examples referenced in this letter we believe it is our duty, as the Board, to censure Mr. Adams. As with any stakeholder or Board Member, they are welcome to hold any personal views. We must, however, respond to the use of language that is against the values of the Department of Neighborhood Empowerment, and the Studio City Neighborhood Council. While representing the public, we must protect ethical standards for public safety, inclusivity, and decorum.

The Los Angeles Emergency Rental Assistance Subsidy Program will provide a temporary rent subsidy for tenants who live in the City of Los Angeles and are unable to pay rent due to circumstances related to the COVID-19 pandemic. Eligible tenants are those whose household income is at or below 80% of the Area Median Income, which is \$83,500 for a family of 4. The rent subsidy will be paid directly to the tenant's landlord on the tenant's behalf. The program starts in July.

The Outreach committee presented a Proclamation, Awarding the first-ever Studio City Neighborhood Council Award for Outstanding Community Service to Erica Fox and Bipasha Strom for their efforts in creating and efforting the Juneteenth Walk in the Colfax Meadows neighborhood uniting cultures and bringing the community out for a healthy, safe, and informative 3-day event. Both will receive a plaque and copy of the Proclamation, as well as recognition from Paul Krekorian's office and the City of Los Angeles. Mark Fisher will point the creation of the award. The President will front the City recognition.

The Committee made a commitment to the Studio City Public Library and the Studio City Recreation Center to usher in a new era of coordination and cooperation among these vital community assets.
