

Since the pandemic, bulky items are piling up. LAPD and the Hope/Care team have been setting up cleanups without resources to effectively get the most problematic areas cleaned up and bulky items removed.

We are aware of your office's assistance in the past and appreciate it, but we ask that more attention be paid now. The increasing population of those unhoused, currently living on our streets has led to an increase of trash and blight which presents an immanent unsanitary health risk, both to those living on the street and the greater community.

BUDGET COMMITTEE Report for the SCNC AUGUST 2020 Agenda

On JULY 20, 2020 the SCNC Budget Committee met with all committee members in attendance.

A representative from the Studio City Beautification Committee, Andrew Epstien presented a funding request to the committee for consideration of the Vineland Avenue Medium Improvement Project. The committee voted to send this to the council for approval.

There were written comments sent in by two stakeholders to be read during the consideration of this motion. One in favor, one opposed. I read both out loud for all to hear on the zoom call, which was also recorded. They are included here for the record.

FROM BARRY JOHNSON:

Regarding Agenda Item # 6... I just want to say (as an SCBA Board Member) that I wholeheartedly support this funding request and would like to remind the committee members that Vineland Avenue from Ventura Boulevard to Chandler Boulevard is a Los Angeles City designated Scenic Highway. This designation came when the old Red Car light rail transit tracks were removed from Vineland Avenue in the late 50's and the center planted median was created. The Red Car had come over the Cahuenga Pass to Studio City and continued to Canoga Park or San Fernando from Vineland and Chandler (via Van Nuys).

My hope is that this center re-beautification in Studio City between Ventura and Whipple will encourage our N/C's to the north (Greater Toluca Lake NC and NoHo NC) to take their lead from us and continue to beautify the whole length of this designated City Scenic Highway. I say re-beautification, because the drought of a few years back had Governor Brown shutting off the water to all medians in the state. Our Vineland Median with its trees and grass truly suffered, but the re-beautification efforts this time will be comprised of drought tolerant plants.

OUTREACH COMMITTEE

August 2020 Outreach Committee Meeting Summary

On August 10, 2020 the Studio City Outreach Committee held a regular meeting. In attendance were the Committee Chair, and Committee Members Alli Spotts-De Lazzer, Mark Fisher, Raduca Kapaln, Nancy Kremer, Scott Mandell, and SCNC President Randall Fried (ex-officio) and quorum was established.

July minutes were filed without objection.

The committee has adopted a new mission statement pending Board approval. Motion to adopt the new verbiage as amended passed by a unanimous vote.

The mission of the Outreach Committee is to:

- Ensure that every Studio City stakeholder feels connected to and heard by the Studio City Neighborhood Council;
- Engage stakeholder participation in meetings issues and events involving Studio City and surrounding communities.;
- Provide the path between the City of Los Angeles services and information and Studio City stakeholders;
- Promote the visibility of the Studio City Neighborhood Council.

The Outreach Committee presented the SCNC August 2020 Award for Outstanding Community Service to Greg Fitzpatrick for his work above and beyond expectations in the SCNC's Neighbors Helping Neighbors program during the COVID-19 crisis. Motion to adopt the Proclamation as amended passed unanimously.

The Chair gave a social media report. Facebook remains our leading Outreach engagement platform. Page views were up 28% per week, however post engagements were down 14%, leaving the social media relatively flat for the month. It is our hope that the planned mailer would cause a spike in Facebook page "likes."

The Chair has opened up the printing of various materials (banners, proclamations, awards, and mailings) to a number of local vendors to spread the work and save money.

- NuColor is our printing vendor for the Outstanding Community Service Award Proclamation.
- Arnold's will handle the postcards and physical mailing (though whether we engage the USPS or go door-to-door is still under consideration). Arnold's uses a service that can

target individual blocks as opposed to the entire zip code—which cuts costs nearly in half.

- King Trophy in Burbank will construct our physical Outstanding Community Service Award plaque
- Radford Graphics is working on new vinyl banners with the current SCNC logo

The greatest issue under consideration by the Committee is the mailing. The committee is

divided between not spending the money on a physical USPS mailing versus handing out the mailing door to door or via some other process. Up for discussion is whether a concise or detailed wording on the postcard is preferred. Born out of this discussion was a suggestion that we tie the mailing to a survey posted to the SCNC website. The survey (accessed through a QR code on the mailer) would give stakeholders a chance to answer questions about which issues most concern them about Studio City. The format would be multiple choice, and a potential write-in slot. The questionnaire would also create a point of contact to collect new email addresses for the SCNC distribution database, with the goal of further expanding our outreach touch points. The mailer would also include the information on where to subscribe to the various SCNC portals including email, website, Facebook, Instagram, and Twitter platforms. The Committee was given the assignment of submitting potential questions for the survey, and a Special Meeting of the Outreach Committee is scheduled for August 26.

To support the mailing it was suggested that we pre-authorize up to \$6000 dollars for the USPS post card printing and mailing, in the event we decide to use the USPS for distribution.

Emily Aaronson from The Studio City Public Library gave a library update. The SCPL has a "Library To Go" program for members to check out books in the absence of an open public space. Learn about the program here: https://www.lapl.org/library-to-go and the SCNC has since promoted the program as a part of our ongoing commitment to help cross-promote and partner with both the Studio City Public Library and the Studio City Recreation Center.

On the topic of SCNC Shirts, we are discussing having Polo-style shirts made, black with a white SCNC logo, for future events. As we are not allowed to have in-person gatherings, that discussion is tabled for future debate.

A brief discussion took place about possibly acting on some of the various websites and platforms that appear to be SCNC related, to which we have no affiliation.

We have also committed to better collaborating with other Committees and their work.

The Public Safety Committee requests the Studio City Neighborhood Council to draft a letter to Councilmember Paul Krekorian requesting the assistance in obtaining a Department of Sanitation Trash Truck along with a sanitation worker(s) for deployment in the North Hollywood LAPD Station Division's area in an effort to assist the homeless with trash and blight.

Since the pandemic, bulky items are piling up. LAPD and the Hope/Care team have been setting up cleanups without resources to effectively get the most problematic areas cleaned up and bulky items removed.

We are aware of your office's assistance in the past and appreciate it, but we ask that more attention be paid now. The increasing population of those unhoused, currently living on our streets has led to an increase of trash and blight which presents an immanent unsanitary health risk, both to those living on the street and the greater community.

PS MOTION 2:

Due to the possibility of up to 400 people being in residence at the Sportsman's Lodge, Project Room Key, the Public Safety Committee requests that the SCNC send a letter to Ben Besley of Sportsman's Lodge, Paul Krekorian, CD2, and LAHSA, DSS (Department of Social Services) and Project Room Key requesting additional security besides already established security enhancements, camera surveillance, and security personnel on site 24/7.

SCNC Sustainability Committee Unanimous Vote: 6-0-0

The Studio City Neighborhood Council, representing more than 35,700 resident stakeholders, supports Councilmember Paul Koretz's motion to ban unnecessary vehicle idling in Los Angeles. Such a ban would help the City achieve the air quality goals established in the Sustainable City pLAn.

Research has consistently found that it's less polluting and more fuel efficient to turn off a fuel-injected vehicle than let it idle for more than 10 seconds. Air pollution impairs everyone's quality of life. It damages lungs, hearts, brains, skin and other organs; it increases the risk of disease and disability, affecting virtually all systems in the human body. Evidence presented at a recent hearing of the House Committee on Oversight and Reform reveals that the health effects of air pollution are roughly twice as bad as previously estimated.

Eight states and many cities have already implemented vehicle idling bans. We support adopting the best practices from these places, including exemptions for extreme temperatures, the health and the well-being of passengers, any safety or emergency vehicles, and the needs of certain commercial vehicles to run their engines while parked.

We need an effective ordinance coupled with a meaningful educational campaign by LADOT to help raise public awareness about the public health impacts of parked idling, including the posting of signage in highly sensitive areas. The Studio City Neighborhood Council, calls on LA City Council to support the Los Angeles ban on unnecessary vehicle idling.

Lankershim Boulevard protected bike lanes

WHEREAS treatment for Lankershim Blvd. in the Mobility Plan includes a protected bike lane;

WHEREAS Los Angeles typically modifies street configurations during street repaving;

WHEREAS the "ADAPT" program by StreetsLA is dramatically accelerating the repaving of commercial corridors during the COVID-19 traffic Iull;

WHEREAS Lankershim Blvd. between Whipple St and Cahuenga Blvd. is scheduled to be repayed soon;

THEREFORE we ask that the Los Angeles Department of Transportation, in coordination with StreetsLA, implement the 2035 Mobility Plan as approved by the City Council when repaving Lankershim Blvd., adding a parking protected bike lane on both sides of the street. We understand this may require a lane reconfiguration, reallocating space from vehicle traffic to active transportation. If for any reason this is not possible then we ask that you delay repaving until such time that the Mobility Plan can be fully implemented.

August 5, 2020 Transportation Committee Meeting Report

- Sent Motion to Board to request Councilmember Krekorian to instruct LADOT to install a full traffic signal at Laurel Canyon Boulevard and Dona Dorotea Drive where a traffic calming measure is needed to deter northbound, downhill speeding where many accidents involving vehicles into property have occurred.
- Discussed the Board of Transportation Commissioners' list to the City Council Transportation Committee to eliminate or modify existing Preferential Parking Districts (PPD's) Citywide near parks, beaches and hiking trails. In Studio City this list includes PPD 111 for Fryman Canyon, Iredel Canyon and Wilacre Park as well as PPD 170T for Coldwater Canyon Park and Wilacre Park. Discussion of CD2's Jessica Fugate's letter saying they will contact the Chair of the City Council Transportation Committee. Nothing will happen without Councilmember Krekorian's full review. Fryman/Iredel residents reminded the committee of extremely narrow streets and extreme fire danger... which was one of the primary reasons for these two PPD's in the first place.
- Updated the progress of the implementation of Councilmember Krekorian's Neighborhood Traffic Management Plan located south of Ventura Boulevard, between Lankershim Boulevard and Whitsett Avenue, which has been moving slow due to Covid-19 delays.
- Update on the start date of the fully funded new traffic signal at Ventura Boulevard and Berry Drive, which has not moved forward due to Covid-19 delays.
