The Studio City Neighborhood Council asks our city and state officials to immediately consider updated measures, provide detailed reports, seek community input and enact laws taking emergency action to improve the current situation.

As we begin 2019, we strongly advise that the issue of mental health becomes a top agenda item for lawmakers. Furthermore, the trifecta of <u>Prop. 57</u>, <u>AB109</u> and <u>Prop. 47</u> – which

adversely changed our state's approach to crime, punishment, drug and mental health care – needs a careful examination and reform.
