As a community we are tasked with rethinking how we approach public safety and emergency response. To do so we must evaluate the jobs we as a society have asked law enforcement to do, determine what is effective what is not and to reallocate those funds accordingly. On June 30<sup>th</sup> the city council voted unanimously to replace LAPD officers with nonviolent crisis response teams to handle "mental health crisis, substance abuse, neighbor disputes etc". Councilmembers Marqueece Harris-Dawson, Mike Bonin, Curren Price and Herb Wesson suggested that the city consider using L.A. Department of Transportation staff or automated technology to enforce traffic laws, including speeding, illegal turns, and other vehicle code violations. Is this proposal in the best interest of public safety?
