Summary: Regarding LAPD Presence at Bridge Home: The Central San Pedro Neighborhood Council's Public Safety and Transportation Committee appreciates the commitment of two LAPD officers which are to be present 24/7 around the area of the Bridge Home located at 407 N. Beacon St. as discussed numerous times with the community. We understand the LAPD is expecting budget changes and we want you to consider the following issues: Whereas, the San Pedro Bridge Home is a "low-barrier" homeless shelter (whereby no initial background check is required), Whereas, some residents are struggling with addiction, mental and/or physical illnesses, Whereas, local gang-activity is well-documented in the neighborhood, Whereas, the Bridge Home is located in a well-established residential community, It is resolved that the Central San Pedro Neighborhood Council's Public Safety and Transportation Committee supports the funding of two officers from LAPD who patrol 24/7 surrounding the Bridge Home area for at least three years, as promised by the Mayor and Council Members.

Studio City Neighborhood Council Committee Meeting Agendas are posted for public review on the SCNC website at studiocitync.org and at the CBS Studio Center Radford and Colfax gates.

The SCNC meetings are held on an active studio lot. Due to security issues, all stakeholders are required to park in the studios parking structure. There are a limited number of accessible parking spaces in front of the meeting room and while there is no direct path of travel to the meeting room via a sidewalk, the studio and NC want to assure that stakeholders with disabilities are able to access the meeting without difficulty.

Stakeholders with disabilities who have a valid DMV placard, use a wheelchair, walker or cane, and/or those who have difficulties walking distances should contact (323) 828-2149 or rfried@studiocitync.org to request shuttle assistance at least 24 hours prior to the meeting in order for the studio to arrange services for the meeting.

PUBLIC INPUT AT NEIGHBORHOOD COUNCIL MEETINGS

The public is requested to fill out a "Speaker Card" to address the Board on any item on the Agenda PRIOR to the Board taking action on an item. Comments from the public on Agenda items will be heard only when the respective item is being considered. Comments on other matters, not appearing on the Agenda that are within the Board's subject matter jurisdiction, will be heard during the Public Comments on Non-Agenda Items period.
