Application of the City's Tree Guarantee Fee (aka In Lieu of Fee) shall be excluded. This motion is also to be submitted as a Community Impact Statement (CIS) to [CF21-1414]

c. Motion: The Studio City Neighborhood Council (SCNC) strongly supports Council File 21-1470 for an ordinance to amend City code to ensure the City provide the right of first refusal for the purchase of City-owned surplus property in the Santa Monica Mountains to the Santa Monica Mountains Conservancy, as required by State Law. The City of Los Angeles is the owner of many environmentally sensitive parcels in the Santa Monica Mountains, including land that contains the highest concentration of biodiversity, habitat for protected species such as the local mountain lion, protected native trees, and sensitive natural woodlands. In the past, the City has sold these parcels off for development. This practice is in opposition to a conservation and environmental standpoint and conflicts with state law - which provides that the resource agencies such as the Santa Monica Mountains Conservancy should be provided the first opportunity to acquire these parcels for permanent preservation of open space. We agree with the comment submitted to the file by CLAW: "It is important that the City we have a fail-safe program and never again make shortsighted attempts to sell away and develop irreplaceable city-owned land which has an inherent value and long-term benefit for the wellbeing of the environment and all Angelenos". We urge City Council to approve the ordinance. This motion is also to be submitted as a Community Impact Statement (CIS) to [CF 21-1470]

An appeals board composed of 3 Neighborhood Council Board Members from different Neighborhood Councils shall meet and review any DONE findings and input from the accused Board Member and affirm or overturn the suspension by a majority vote. Said appeals body shall decide within ___ days of meeting and inform all interested parties of the decision. The ruling of the appeals body shall be final."
- (5) How can D.O.N.E partake in direct disciplinary action against the NC system if Article 9 of the Los Angeles City Charter created DONE to "assist," "arrange," and "advise" Neighborhood Councils, and the words "discipline" or "disciplinary body" do not exist?
- (6) Has the City Attorney's office done an analysis about the likelihood of lawsuits by elected Board Members because of the due process or other problems in the proposed Code of Conduct?
- (7) The Attachment A restrictions to the proposed Code of Conduct potentially violate the First Amendment rights of elected Board Members and Committee Members.

WHEREAS, the Department of Neighborhood Empowerment (DONE) refers to Neighborhood Council Board Members as "volunteers who are public officials elected by their communities and serve in an advisory role to municipal government", rather than elected and appointed public officials who volunteer their time; and

WHEREAS, DONE's draft Neighborhood Council Board Member Code of Conduct proposes the disciplining of elected Neighborhood Council Board Members by unelected, appointed DONE employees;

IT IS RESOLVED that:

The Board of the Studio City Neighborhood Council (SCNC) requests clarification from the City Council, the City Attorney and BONC as to (1) whether Neighborhood Council Board Members are city officers under the City Charter; and (2) the legal basis for unelected DONE/City employees being able to suspend or otherwise discipline elected and appointed Neighborhood Council Board Members.

This motion is to be submitted as a Request For Action to Councilmembers Nithya Raman and Paul Krekorian, as well as the City Attorney of Los Angeles and the Board of Neighborhood Commissioners.
