- 10. Sustainability Committee Adele Slaughter & Charles Miller (10 minutes)
 - a. Motion. The Los Angeles region faces a climate and biodiversity crisis. Over 90% of local butterflies, songbirds, and other pollinators have disappeared in the last century due to the replacement of local flora with non-native plant and tree species. Native landscape plants and trees can thrive in our urban environment and furnish all the benefits non-native trees can offer in terms of canopy shade to offset the heat island effect, beauty, and shade for humans, while providing the only path to sustainability for biodiversity, water and energy savings, and elimination of soil amendment runoff pollution. The Studio City Neighborhood Council formally requests that the LADWP provide 24-hour security at their substation at the corner of Arch Dr and Ventura Blvd. Unhoused individuals have been removing trash from the cans at the adjacent bus bench & spreading it over the LADWP grounds and public walkway, breaking & spreading shards of glass, vandalizing the wall and planters parallel to Ventura Blvd, engaging in drug use (heroine, marijuana, etc) and sexual activity, harassing individuals who are utilizing the car-charging station and now camping out on the grounds in cardboard shelters. While LADWP periodically sends maintenance to clean the area, they are unable to dissuade the revolving group of individuals who are now sleeping on the property. This has become a constant nuisance, a health-and-safety issue and has created a slum-aesthetic for the entire neighborhood. The area promotes more criminal activity and invites more unhoused individuals to the property & neighborhood, many of whom exhibit mental health issues and have episodes either on-property or in the adjacent public right-of-way. The amount of activity is increasing

exponentially. We ask the LADWP to provide 24-hour security until such time as the habitual illegal use of the property no longer occurs. We further request the LAPD, LAHSA and elected officials to provide the appropriate resources to assist in alleviating the situation.

14. Government Affairs Committee Barry Johnson (20 min)

a. Motion. The Board of the Studio City Neighborhood Council (SCNC) agrees with City Council File 22-0002-S106 to oppose <u>SB 930</u> (Wiener) which would allow select cities in California to issue permits extending the cutoff time for alcohol sales to 4 a.m., which could lead to an increased

d. **Motion**. The Board of the Studio City Neighborhood Council (SCNC) opposes Council File 22-1200-S43, Mayor Eric Garcetti's appointment of Jennifer Valdivia to the Board of Neighborhood Commissioners (BONC) as a replacement for resigning Commissioner Quyen Vo-Ramirez for the term ending June 30, 2027. The SCNC has a number of concerns about this important appointment, which is not going to be vetted by a City Council committee. First, Ms. Valdivia has no experience in the Neighborhood Council (NC) system. She was neither a member of an NC committee nor

an elected Board member. Experience with the NC system is extremely important, particularly when BONC issues controversial policies such as the Code of Conduct that affect all NCs. Five out of the seven recent BONC commissioners have been former or current NC Board members, which gives them valuable insights that Ms. Valdivia does not possess. Second, she has limited work experience (7 years) other than as a political operative, primarily for the mayor and a LAUSD School Board Member. She has limited private sector and community experience. Finally, Ms. Valdivia omitted from her City Council-submitted résumé her involvement with Aristos Strategies LLC, a lobbying firm founded by her father. She worked there as chief operating officer for nine months, according to her Linkedin page. At a time when DONE is trying to curb the impact and influence of our community-based Neighborhood Council system, we need a commissioner who will be an experienced and supportive voice for stakeholders and NCs, not a rubber-stamp for DONE bureaucrats, city-hall lobbyists, and contractors. BONC and our Neighborhood Councils deserve better.

- 15. Public Safety Jeff Hartwick (20 min)
 - a. **Motion.**The Board of the Studio City Neighborhood Council (SCNC) requests Councilmembers Raman and Krekorian bring forth a resolution opposing the policies and special directives of Los Angeles County District Attorney George Gascon. There has been a crime surge in Los Angeles since the initiation of DA Gascon's policies and directives, from misdemeanors to violent felonies. DA Gascon's newly instituted policies and directives have unquestionably contributed to this surge. For example, DA Gascon issued Special Directive 20-07, which lists numerous misdemeanors that are generally declined or dismissed before arraignment, including resisting arrest, drinking in public, public intoxication, trespassing, and drug and paraphernalia possession. This has directly led to the non-enforcement of quality of life crimes throughout the City. Special Directive 20-08 eliminated certain sentencing enhancements for career criminals, including the Three Strikes Law and gang enhancements. DA Gascon only modified that policy after a judge issued a

preliminary injunction against it for non-compliance with state law. Our DA refuses to enforce cash bail under Special Directive 20-06, which has resulted in a revolving door policy of repeat criminals being set free only to commit more crime while awaiting trial. Only after a few high-profile violent felony cases did he agree to consider cash bail in rare circumstances. DA Gascon "will not defend existing death penalty cases" under Special Directive 20-11, even though California voters support the death penalty. He refuses to send prosecutors to parole hearings. DA Gascon refuses to try juvenile offenders in adult court no matter how heinous the crime. A man recently arrested for the slaying of a homeless man had been released from prison last year after just serving 8 years of a life sentence for double murder because DA Gascon refused to transfer the case from juvenile to adult court. DA Gascon's dangerous policies and special directives continue to endanger all Angelenos, and residents and stakeholders of Studio City are concerned about the DA's non-prosecution of crimes that affect our quality of life. Our laws must be enforced, not undermined by the DA. The time is now for the City Council to support the repeal of these dangerous, ill conceived, and even unlawful policies of DA Gascon. The safety, well-being, and quality of life for all Angelenos are at stake.
