Abigail Velasco:

13. Ad Hoc Committee on the Residences at Sportsmen's Project (Barry Johnson/Peter Cole). Public comment was given. Peter Cole presented a 3D rendering of the proposed project. Public comment was held. Attendee Heidi opposed the project as too large and supported the motion. Cosmo supported the motion. Eric Preven stated the project was a bait and switch and an egregious misuse of space. Teri Austin supported the motion. Joanne supported the motion. Tess Taylor supported the motion. Lauren supported the motion. Lewis supported the motion. Sari was concerned about Valley Fever in the dirt and air quality. Patrice Berlin opposed the project and supported the motion. Jesse supported the motion and suggested repurposing.

The president stated he received 95 emails opposed to the project. Board comment followed.

Ben Besley, of the developer Midwood, answered questions from the Board and stakeholders about the project. He said what people are saying is that the project is too tall. He stated that what Peter Cole presented was "grossly inaccurate." Said it doesn't accurately reflect set-back. Said zero set-back because of underlying zones and slope of building. Said he doesn't know about the \$400,000 re Project Roomkey. He said tried plans over 2 years to repurpose hotel but didn't make financial sense because no weekday business. Said designing for electric vehicles so will help air quality. Ben said there would not be a 3D model forthcoming because seeing things from an aerial view is different from street level view. He stated that he doesn't have a set of plans for a smaller project. He mentioned that he has had conversations with Harvard Westlake about concurrent projects, including alternate truck routes in the event there is concurrency. He said he heard little from others about benefits of the project.

More Board questions followed.

MOTION 13:

The Board of the Studio City Neighborhood Council (SCNC) *opposes* Los Angeles City Planning Department Case Number: CPC-2021-7012-DB-MCUP-WDI-SPP-SPR-VHCA *unless* the Height is a total of the Ventura-Cahuenga Boulevard Corridor Specific Plan's (VCBCSP) by right allowable height of 30 feet, plus the Los Angeles Municipal Code Ordinance Number 179681 Density Bonus "On-Menu" (by right) Density Bonus of 11 additional feet to provide for the Density Bonus units restricted to Very Low Income households; for a total of 41 feet. Furthermore, the SCNC *opposes* requests for any "Off-Menu" waiver or modification development standard(s) that would have to be approved by the City Planning Commission (CPC), including a request for these seven (7) Off-Menu Incentives at the site:

- 1) An Off-Menu Incentive to allow a maximum Floor Area Ratio (FAR) of 2.83:1 in lieu of the otherwise permitted 1.0:1 FAR, this in excess of the 35 percent increase permitted under LAMC Section 12.25 A.25(f)(4);
- 2) An Off-Menu Incentive to allow a maximum building height of 94 feet in lieu of the otherwise permitted 30 feet plus the additional 11 feet granted by LAMC Section 12.25 A.25(f)(5) for a total of 41 feet;
- 3) An Off-Menu Incentive to allow 402 accessible standard vehicle parking stalls in lieu of the otherwise required 520 accessible standard parking stalls;
- 4) A Waiver to allow zero-foot side yard setbacks in lieu of the otherwise required 10-foot side yard setbacks as required by LAMC Section 12.22 C.20;
- 5) A Waiver to waive the otherwise required transitional height requirements as established by LAMC Section 12.21.1 A.10 for buildings in a C or M Zone within certain distances of an RW1 or more restrictive zones including OS zones;
- 6) A Waiver to allow a zero-foot distance between main buildings in lieu of the otherwise required distance;
- 7) A Waiver to allow a zero-foot rear yard setback in lieu of the otherwise required 20-foot rear yard setback as required by LAMC Section 12.11 C.3.

The "Off-Menu" items that the CPC would have to approve go completely against the Ventura-Cahuenga Boulevard Corridor Specific Plan's (VCBCSP) "Neighborhood and General Commercial Plan Designation" (the least developed of three designations within the VCBCSP; a land-use designation which is a focal point for surrounding residential neighborhoods and containing a diversity of land uses, such as restaurants, retail outlets, grocery stores, child care facilities, small professional offices, community meeting rooms, pharmacies, religious facilities and other similar services. Additionally, Ventura Boulevard has the "Boulevard II" street classification, but Coldwater Canyon Avenue has only the "Avenue II" classification, a much narrower roadway which carries the vehicle traffic between the entire Valley and Beverly Hills and beyond. This is one of the busiest intersections along the entirety of Ventura Boulevard and is on the "Critical Intersections" list of the VCBCSP. The VCBCSP has the purpose to assure a compatible and harmonious relationship between residential and commercial development where commercial areas are contiguous to residential neighborhoods, as well as, assuring that an equilibrium is maintained between the transportation infrastructure and land use development in the VCBCSP and within each separate community of the Ventura-Cahuenga Boulevard Corridor Specific Plan area.
