## 5. Treasurer Report Kim Clements (15 min extendable by chair)

So I wanted to. We did have a chance as a budget committee to meet which we meet so infrequently, but did recently. We have a number of things ahead of us in this agenda, having to deal with the financial requests funding requests. So wanted to bring you all up to speed, because our budget is a bit tight this year, depending on a few things. The fiscal year ends the end of June, and if we could share the current budget by the way, this is not a motion. This is just a presentation and discussion, so that everybody on the board is aware of our current financial position, and as well as stakeholders who may be seeking funding. the cash balance on. There's 2 we've got on the left. There is the pretty. It's pretty fair. The possible is slightly less likely, but just an alternative to give a sense of what we may be looking at the cash balance for both on both sides is 29,000, with 29,000 currently remaining. We have promised that no payment has yet been made to on the second line there 5,000 to the SCBA. The Studio City Beautification Association. We, as a board, did approve that Median project. We and do anticipate paying that out in this fiscal year. We have 2 movie nights approved. We had, and it the one already. In September we had 2 additional approved. So that earmarked for that is 5000 Out of the 29,000. The first one, though I do want to point out, came to about. I think it was about \$1,600. Let me just double check this no around 1,800, so that the 2,500 is a little high for each one. But we do not yet know what might, what we might run into and need. The election there at 8,000 has been up in the air as to how much, and we'll talk later on that as to just how much of we spent. I think, last year there have been numbers thrown around about 1011000 for the last election. Mailings are very expensive, so it depends on whether that is something that we want to do could be as little as 4 Or 5,000. I have got some input from done, and I appreciate. Thank you, Lorenzo, for getting back to me today that that is kind of a target. But all of this is in our hands. As to what we decide the rest there we have meeting refreshments. And actually. I have to apologize. I did get the numbers right. I was overthinking this the other night, not looking at it. Pardon me, but they are. The numbers are correct, but the 4 months for various things. Kim Clements: These are all, of course, dependent on whether we vote later in the meeting for not all these, but some of them the minutes take or tech assistance. Those are up in the air. The other things are. It kind of guesses so many ways. If we follow this. Kim Clements: there's a \$2,900 remainder, which can be carried over up to 10000, would be carried over to the next fiscal year, which we have had the pleasure of this year, and in prior years 32,000 is the normal budget, which is very small to work with. Here we're running low with 42,000 is what we started out with this year. So the possible side there I had moved. The election budget of 8,000 is what we currently budgeted for. Kim Clements: But again, that's up in the air. I reduced it to 4000. If we possibly were going to go that light as well as I took away some things like the tech assistance for the meetings. However, in the original pro form. I targeted a 1,000, but we do think it may be more like 2,000. So hence was the reason reasoning for the cushion at the end there of the of the left side of a 3,000 cushion. But on this possible side I removed it. If we're really

squeezing our dollars and don't do any of that? 10,900 look like a remainder, I think fair would be somewhere in the middle of 5 Or 6,000, so that is currently what we would end up with at the end of the year, just looking at these things here.

Kim Clements: But again I will see we'll see what happens. But I wanted to give people a fair perspective of what of what we have left, and where the money is already promised, where it's going. just so that we're all aware, and can make better decisions with our finances.





I don't know how she's going to do it, because it's a State law and State supersedes local. But our city attorney used to be the Vice President of Pico and C. And used to be the Co. Chair of the Land Use Committee over there. So she is well and she initiated with the Nc. System, being one of us before she ran for city attorney. So if there is any possibility that she can somehow help us, I'm sure she will. Outside of that I have nothing more to add.

# PUBLIC SAFETY WAS NOT DISCUSSED. THESE ITEMS WILL BE DISCUSSED IN MARCH BOARD MEETING

**a.Motion** The Board of the Studio City Neighborhood Council (SCNC) supports Council File 22-1594: Title, Hazardous and Illegal RV Parking / Resident Complaints / Oversized Vehicles / Parking Enforcement. After a deluge of complaints from Los Angeles residents about the proliferation of immobile and unsafe recreational and oversized vehicles in the City, the Board of Transportation Commissioners recently investigated the chronic problem. The

Transportation Commissioners found that there was an increase in crime on impacted streets, enhanced risk of fires, illegal drug use, dumping of trash, and blocking of cyclists. Offending Recreational Vehicles (RVs) and oversized vehicles were also not being cited by authorities. The Commission drafted a report with recommendations for the City Council to implement. These important recommendations include:

- (1) Begin immediate parking enforcement of oversized vehicles in violation of LAMC Sections 80.69.4 and 80.69.
- (2) Request that the Mayor declare an emergency regarding the proliferation of these vehicles so that the impacted streets can be immediately cleared.
- (3) Immediately install parking restriction signage in impacted areas.
- (4) Adopt a citywide ordinance prohibiting oversized vehicle in all residential-zoned areas, like many municipalities have done across the U.S. The Board supports these common-sense recommendations for immediate action that will bring order to chaotic areas that have become drug dens, hubs of criminal activity, and sources of environmental pollution and public health hazards.

B. **Motion** The Board of the Studio City Neighborhood Council (SCNC) supports Council File 21-1465: Title, Los Angeles Police Department / Property Crimes / RV Overpopulation. In February 2022, the City Council adopted the Public Safety Committee report of this council file seeking reports from the Los Angeles Police Department (LAPD) and Fire Department (LAFD) about crime and fires along Recreational Vehicle (RV) corridors in the City. The LAPD drafted a report in May 2022 addressing the RV crime issue, which was approved by the Los Angeles Police Commission in December 2022. There are 216 specific locations where oversized vehicles and RVs have a positive correlation with increases in crime. The 49 most problematic RV areas were spotlighted, including seven RV encampments in the North Hollywood district. In the North Hollywood area encampments, there was between an 83%-150% increase in crime, the worst being the Tujunga Ave./Hartland St. encampment.

Noteworthy findings/conclusions include:

- (1) Crime numbers are elevated within RV encampments.
- (2) There will be an increase in RV presence unless more restrictive parking regulations are enacted.
- (3) Outreach efforts should occur prior to enforcement.

- (4) There should be a Modus Operandi (MO) reporting code associated specifically with RV crime to get more data.
- (5) There needs to be more RV salvage recycling facilities to dispose of scrap RVs.

The Board urges the City Council to address these findings with new ordinances and funding to stop the proliferation of RV encampments and associated increases in crime.

- 14. **Motion:** The Board of the Studio City Neighborhood Council (SCNC) opposes Case No. <u>DIR-2022-1022-SPP-SPPA-WDI</u> at 12218, 12220 and 12222 Ventura Boulevard for the following reasons:
- 1. The intent of the Ventura-Cahuenga Corridor Specific Plan's 30 foot height limit on the southside of Ventura Boulevard between Laurel Canyon Boulevard and Whitsett Avenue is to not have 3-story buildings. Page 9 of The Planning Department's <a href="Determination Letter">Determination Letter</a> even states:

"The surrounding properties are developed with one or two-story commercial retail buildings along both sides of Ventura Boulevard and single-family dwellings across from the alley at the rear of the property. The Ventura/Cahuenga Boulevard Corridor Specific Plan designates the subject property for Community Commercial land uses which are a 'focal point for surrounding residential neighborhoods and containing a diversity of land uses, such as small offices, retail, cultural facilities, schools and libraries, in addition to neighborhood-oriented services' ".

Currently, there are no 3-story buildings on Ventura Boulevard between Vantage Avenue and Rhodes Avenue, the block where this 3-story building is proposed. The block is comprised of mainly 1-story buildings with a few 2-story buildings mixed in.

To say (on Page 12 of the Determination Letter):

"The strict application of the Specific Plan would result in practical difficulties and would render the proposed project infeasible",

This is, of course, true, because the Applicant wants to build 3-stories high on a block where there are no 3-story buildings.

To say (on Page 12 of the <u>Determination Letter</u>):

"The Specific Plan's 30-foot height limit is impractical as it would not permit a commercial building with sufficient height to accommodate three floors of uses...",

is also true because, again, the Specific Plan's intent is to prevent 3-story buildings on the southside of Ventura Boulevard between Laurel Canyon Boulevard and Whitsett Avenue.

To say (on Page 12 of the Determination Letter):

"The development standards are limited by the Specific Plan."

YES, that's the reason for a Specific Plan in the first place.

"While appropriate for maintaining a reasonable amount of commercial development in the midst of low-density housing".

Yes, single-family homes are directly adjacent to the same subject property alley from Vantage Avenue all the way to Whitsett Avenue.

To say (on Page 13 of the Determination Letter):

"The unique design requirements and building characteristics of a commercial building cannot be accommodated within the parameters of the Specific Plan regulations, specifically the site's height limitations, and without the adjustment, it is impractical and infeasible to build such a building on the subject property",

is again, only true because the Applicant wants to build 3-stories high on a block where there are no 3-story buildings. How is this (on Page 9 of the Determination Letter), a:

- "... focal point for surrounding residential neighborhoods..."?
- 2. The SCNC opposes the proposed project's "Roof Terrace". This essentially places an open-air 4th story on the building, and even though it may be at the front of the building, noise will carry to the single-family residences immediately behind the proposed building.
- 3. The SCNC opposes the proposed project's front yard setback of 3 feet, 7 inches. The rest of the buildings on this block of the subject property only have an 18 inch setback. There is absolutely no need to make this proposed building further stand out in the crowd with an increased setback.

15.**Motion**: The Board of the Studio City Neighborhood Council (SCNC) supports Council File 23-4118-S2: Title, Designation of Prohibited Locations / Riverside Drive and 134 Freeway / North Hollywood Red/Orange Line Station / North and South Weddington Park / Vineland Avenue and 134 Freeway, etc. / Council District 2/ Los Angeles Municipal Code Section 41.18. Homeless encampments are again on the rise in and around Studio City, including at Riverside Drive/134 freeway, Vineland/134 freeway, Tujunga/101 freeway, the Red/Orange Line station, and South Weddington Park.

Open drug use, fires, litter, unsanitary practices, sidewalk obstructions, and criminal activity is rife in these areas. Residents and stakeholders have complained about these unsafe and growing encampments and want more to be done. A 41.18 special enforcement zone designation would prevent individuals from sitting, lying, sleeping, or storing, using, maintaining, or placing personal property, or otherwise obstructing the public right of way. The SCNC applauds Councilmember Krekorian for introducing this important resolution that will give the LAPD an enforcement tool to deal with the service resistant. We hope that Councilmember Raman also supports this 41.18 designation to ensure that our residents, disabled persons, and children can safely travel through these troubled areas of Studio City.

Homeless encampments are again on the rise in and around Studio City, including at Riverside Drive/134 freeway, Vineland/134 freeway, Tujunga/101 freeway, the Red/Orange Line station, and South Weddington Park.

Open drug use, fires, litter, unsanitary practices, sidewalk obstructions, and criminal activity is rife in these areas. Residents and stakeholders have complained about these unsafe and growing encampments and want more to be done. A 41.18 special enforcement zone designation would prevent individuals from sitting, lying, sleeping, or storing, using, maintaining, or placing personal property, or otherwise obstructing the public right of way. The SCNC applauds Councilmember Krekorian for introducing this important resolution that will give the LAPD an enforcement tool to deal with the service resistant. We hope that Councilmember Raman also supports this 41.18 designation to ensure that our residents, disabled persons, and children can safely travel through these troubled areas of Studio City.
