#### Brandon Comments:

Brandon Morino: First of all, I'm really disappointed in this motion. We were expecting this motion to be brought in February, not March. It's a month late. as far as we can tell. First. Really quick. True. Scott's correct. I have not been responding to a lot of his emails, some emails. Yes. But as there is such a thing as a loaded question, there is also such a thing as a loaded email. and I do not respond to loaded emails. Loaded emails are basically emails are not looking for an answer. If they're looking to start a fight. I don't respond to them at all. Now outside of that. If anybody reads our operating procedures, Article 2 section one be on the duties of the Vice President. It's very clear what the duties of the Vice President is. I'm gonna have to read them for you. But you want me to really, really quick. One act as the presiding officer of board meetings in the absence of the President, 2 assume the responsibility is an act in the capacity of the chair during any period in which the President is unavailable. 3 supervised grievance panels. as requested by the Bylaws committee, and 4 perform such other duties as the Board may direct from time to time. Now, even though it is true that I have not responded. A lot of Scott's emails.

Richard Niederberg: not responding to emails is not one of the duties of the Vice President.

Brandon Morino: It's not as professional as I'd like to be. That's true. But I have not failed in my duties as the Vice President's per our laws at which we are abided to these are laws. They're on a piece of paper, and you can read them. Now, to be perfectly honest with you. I really don't care which way this vote goes, because it's not about my duties. It's really about 2 things. January twelfth and February second. That's it.

Richard Niederberg: That's all it's about, and

I dropped. I left as chair of outreach, and you just went ahead and removed me from outreach altogether, which is a violation. 10. Public Safety Committee (Jeff Hartwick 20 min extendable by chair)

**a. Motion** The Board of the Studio City Neighborhood Council (SCNC) supports <u>Council</u> <u>File 22-1594</u>: Title, Hazardous and Illegal RV Parking / Resident Complaints / Oversized Vehicles / Parking Enforcement. After a deluge of complaints from Los Angeles residents about the proliferation of immobile and unsafe recreational and oversized vehicles in the City, the Board of Transportation Commissioners recently investigated the chronic problem. The Transportation Commissioners found that there was an increase in crime on impacted streets, enhanced risk of fires, illegal drug use, dumping of trash, and blocking of cyclists. Offending Recreational Vehicles (RVs) and oversized vehicles were also not being cited by authorities. The Commission drafted a report with recommendations for the City Council to implement. These important recommendations include:

(1) Begin immediate parking enforcement of oversized vehicles in violation of LAMC Sections 80.69.4 and 80.69.

(2) Request that the Mayor declare an emergency regarding the proliferation of these vehicles so that the impacted streets can be immediately cleared. (3) Immediately install parking restriction signage in impacted areas.

(4) Adopt a citywide ordinance prohibiting oversized vehicle in all residential-zoned areas, like many municipalities have done across the U.S. The Board supports these common-sense recommendations for immediate action that will bring order to chaotic areas that have become drug dens, hubs of criminal activity, and sources of environmental pollution and public health hazards. This motion is also to be submitted as a Community Impact Statement (CIS) to Council File [22-1594].

**b**. **Motion** The Board of the Studio City Neighborhood Council (SCNC) supports <u>Council File</u> <u>21-1465</u>: Title, Los Angeles Police Department / Property Crimes / RV Overpopulation. In February 2022, the City Council adopted the Public Safety Committee report of this council file seeking reports from the Los Angeles Police Department (LAPD) and Fire Department (LAFD) about crime and fires along Recreational Vehicle (RV) corridors in the City. The LAPD drafted a report in May 2022 addressing the RV crime issue, which was approved by the Los Angeles Police Commission in December 2022. There are 216 specific locations where oversized vehicles and RVs have a positive correlation with increases in crime. The 49 most problematic RV areas were spotlighted, including seven RV encampments in the North Hollywood district. In the North Hollywood area encampments, there was between an 83%-150% increase in crime, the worst being the Tujunga Ave./Hartland St. encampment.

Noteworthy findings/conclusions include:

(1) Crime numbers are elevated within RV encampments.

(2) There will be an increase in RV presence unless more restrictive parking regulations are enacted.

(3) Outreach efforts should occur prior to enforcement.

(4) There should be a Modus Operandi (MO) reporting code associated specifically with RV crime to get more data.

(5) There needs to be more RV salvage recycling facilities to dispose of scrap RVs.

The Board urges the City Council to address these findings with new ordinances and funding to stop the proliferation of RV encampments and associated increases in crime.

This motion is also to be submitted as a Community Impact Statement (CIS) to Council File [21-1465].
